RE: Submission of 2006, 2007, and 2008 Annual Report for Licence No. NWB4NUN0511

Dear Mr. Wilson:

The Nunavut Water Board (NWB or Board) received on December 20, 2010 from Nunatta Environmental Services Inc. the 2006, 2007 and 2008 Annual Reports required under the terms and conditions of Licence NWB4NUN0511 (1BR-NUN0511). On January 6, 2011, the NWB acknowledged receipt and distributed the documents to the public for information purposes. No comments have been received to date.

The review of the documents determined that they are inconsistent with the reporting requirement under the Licence. The Licensee is advised that the following reporting requirements remain outstanding in each of the documents submitted:

- Part B, Item 1a: Summary report of water use activities:
 1. Quantity of water collected as surface runoff from the site or collected within the bermed cells;
 2. Quantity of water discharged daily to the treatment cells;
 3. Quantity of water discharged to the receiving environment;
- Part B, Item 1b: Summary of waste disposal activities:
 1. Characteristic of the soils present at the landfarm including the following: origin/source, volume and characteristic for each year being reported;
 3. Rate of degradation;
 4. Treatment Efficiency
 5. Location and quality of discharge effluent from Cells and/or Water Treatment Facilities;

- Part B, Item 1(c): A list of unauthorized discharges and a summary of follow-up actions taken;
- Part B, Item 1(e): Progressive reclamation work undertaken
- Part B, Item 1(g): Tubular summaries for all data and information generated under the Monitoring Program
- Part B, Item 1(h): An analysis of data collected during the Monitoring Program and a brief description of any future studies planned by the Licensee;
- Part B, Item 1(i): Any other details on water use or waste disposal requested by the Board by November 1 of every year;
