Good Afternoon Steve,

I have a draft deliverable from the EWG under review. Following acceptance of this deliverable, we have a contract amendment in place with Arcadis to ask them to review the EWG's position and reconsider their recommendation if warranted. I hope to have a complete package in a few months' time. Our NTI meeting has been re-scheduled for next week.

The EWG wrote the following in relation to the CAM-4 Tier II Disposal Landfill in the draft deliverable received:

"The EWG supports maintaining the current monitoring schedule of Year 2021 to assess Feature K at that time. Based on photographs, dimensions and description provided by the contractor, the EWG assesses Feature K as "acceptable", as this new features dimensions and discontinuous nature is consistent with acceptable ratings. As such, the EWG does not recommend additional monitoring of the landfill prior to the next scheduled monitoring event. "

CAM-4 Tier II Disposal Landfill One new feature identified as Feature K (discontinuous tension crack; northeast slope). Length 9-10m, width 0.05-0.1m, depth 0.05m, <1% extent relative to landfill. Rated as "Marginal". Overall landfill performance rated as "Acceptable".

Hello Mr. Lines,

Thank you for the call as well.

As part of our discussion I am asking our Environmental Working Group to provide a technical summary with more details regarding why they disagree with the Consultant's conclusions/recommendations in the 2016 CAM-4 Monitoring Report. I am doing this under contract through a change order (multiple steps involved with the Contract Authority), and at the moment the earliest possible date that the EWG have told me they can get this to me as a draft is June 22, 2018. I have also discussed this with our Consultant Arcadis, and will give them an opportunity to respond (which may also require a contract amendment – tbd).

With this in mind I don't anticipate having this sorted until the end of July/early August. At this point in time, based on the EWG's review we had not intended on returning to CAM-4 this year; however I can plan for a return to CAM-4 in 2019 if it is deemed to be technically necessary.

I will work on a summary of key issues and recommendations that I can also provide. This cannot be fully completed until the difference in technical opinion is sorted on the 2016 monitoring program between the EWG and the Consultant. I will add it in to the summary as soon as solved, and will send you the complete summary as soon as possible.

Dear Ms. Kharatyan,

Please find this email as a preliminary response to address your largest concerns, we will follow with a letter to address everything shortly.

This email is intended to address 2 concerns: i) the missing monitoring reports; and ii) the 2016 Arcadis Recommendation to monitor CAM-4 annually. Please take a look at the information herein, and advise if you would like to discuss anything further. I would be happy to schedule a call.

Concern 1: Missing Monitoring Reports

On December 15, 2017, DND sent the attached email with a letter to the attention of Ms. Ene to respond to INAC's Letter. With respect to the Monitoring reports, within this letter, DND outlined the following as excerpted below. Should there be any difficulty finding the reports sent on December 12, 2017, we would be happy to resend them. I did not include the emails with the reports again herein at this time due to the file size. They were sent to the attention of Ms. Ene. Please advise if you would like DND to resend these and we will do so right away.

December 15, 2017, excerpt from the letter:

"DND Response:

It is standard practice every year for Defence Construction Canada, on behalf of the Department of National Defence, to submit the annual reports to the NWB once they are finalized. DND conducted a search of the NWB public registry where reports are normally located, and provided on December 12, 2017 another digital copy of any reports not found. Although not on the public registry, the missing reports should be otherwise available at the NWB; the December 12, 2017 submission was for ease of updating the public registry without having to search through historical correspondence.

- 2010: DND emailed a copy of the annual report to NWB on December 12, 2017.

- 2012: Site not monitored, no annual report.
- 2013: DND emailed a copy of the annual report to NWB on December 12, 2017.
- 2014: Site not monitored, no annual report.
- 2015: Site not monitored, no annual report.
- 2016: Located on NWB public registry (http://www.nwb-oen.ca/public/registry/1%20INDUSTRIAL/1B/1BR%20-%20Remediation/1BR-PEL1016%20CAM%204/3%20TECH/10%20MONITORING%20(J)/2016% 20Long%20Term%20Landfill%20Monitoring/)"

Concern 2: 2016 Arcadis Recommendation to Monitor one Feature (Feature K) at the CAM-4 Tier II Facility Annually:

As per Section 7.1 of the Agreement Between Nunavut Tunngavik Incorporated and Her Majesty in the Right of Canada as Represented by the Minister of National Defence for the Clean-up and Restoration of Distant Early Warning Sites Within the Nunavut Settlement Area (NTI-DND Environmental Provisions, September 1998), an Environmental Working Group (EWG) has been established to examine the results of the DEW Line monitoring program. The EWG consists of two members chosen by DND and two members chosen by NTI.

As per Section 7.3 of the NTI-DND Environmental Provisions (September 1998), should changes to the monitoring plan and/or additional remediation be required, the EWG is responsible for making recommendations to the DEW Line Steering Committee on what action(s) should be taken. In accordance with the process, DND then takes action based on Steering Committee decisions.

Please find attached the EWG's letter in response to the more frequent monitoring recommendation at CAM-4. Please see the Summary Letter and Section 4 of the attached Meeting Minutes. The EWG wrote: "The EWG has further reviewed Feature K and concurs with our original assessment that the Feature should be rated as "Acceptable" and not "Marginal". As such, there is no requirement of any additional monitoring in advance of the 2021 monitoring event."

DND's next step would be to discuss this with the NTI at the next Steering Committee Meeting. This meeting was originally scheduled for April 25, 2018, but is now being re-scheduled based on availability (new date to be determined). The NTI (Bert Dean) does have a copy of this EWG letter and the associated meeting minutes.
