The Nunavut Water Board received a new permit application from Defense Construction Canada Ltd. on March 22, 2001 for water use and waste disposal associated with a remote camp and clean up of the former CAM-4 Pelly Bay Distant Early Warning (DEW) Line site.

In accordance with Articles 12 and 13 of the *Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada*, this project shall be screened by the Nunavut Impact Review Board to determine whether it has significant impact potential, and whether it requires review, before the application can be processed by the Nunavut Water Board.
