I had a good call with Laura and Allison at DND re Cam-4 and they will respond by email to provide a timeframe for when they expect to provide a response to the letter that went out.

I reviewed the content of Laura's initial email response explaining that DND's Environmental Working Group didn't agree with one of the recommendations regarding frequency of the landfill monitoring that was suggested by the contractor that went to CAM-4. I explained to Laura that it would be helpful for them in their response to explain further why they don't feel it is necessary. They will address that and anything else of importance that may have arisen from INAC inspection and other site visits by their contractors.

Once we have that we can complete the licence.
