AECOM submitted a notification of modifications on behalf of Defence Construction Canada (DCC) and the Department of National Defence (DND) to water license #1BR-QIK0712, based on the discussion between the Nunavut Water Board (NWB) and Douglas Craig - DCC on February 17, 2009.

The following modifications are being planned as extra clean up work to be done as part of the landfill monitoring program at the FOX-5 Qikiqtarjuaq DEW Line Site. The additional work at this site includes the following:

- Beach Area – Clamming Raft/Barge
- Airstrip Landfill – West
- Reservoir Road Debris Area
- Community Borrow Buried Debris Area
- Main Landfill
- Station Non-Hazardous Waste Landfill
- Middle Site Non-Hazardous Waste Landfill

INAC has reviewed the following documents:
