Hi Phyllis,

We received a modification to this water use license in 2009 (see application and approval attached). We are now adding, at the request of the community of Qikiqtarjuaq, the demolition of another building (heated vehicle storage building at the airstrip area) to the

same work package. All of the hazardous material was removed during the previous clean up work, so it would be dismantling and disposal only. Do I need to send in another request for modification for this? All of the other work will remain the same. It is anticipated that the work will (finally) be completed either this summer or summer 2012.
