Dear Brian Duguay:

On April 1, 2008 the Nunavut Impact Review Board (NIRB or Board) received the Government of Nunavut – Community Government & Services' *Rankin Inlet Fuel Facility Upgrade – Landfarm* project proposal from the Nunavut Water Board (NWB). Before that on March 26, 2008 the NIRB received email correspondence from the Proponent regarding conformity to the Keewatin Regional Land Use Plan (KRLUP) as the project is located within municipal boundaries issued by Nunavut Planning Commission (NPC). NIRB has assigned this project proposal file number 08UN039.

The project is located entirely within the boundary of the Hamlet of Rankin Inlet near the municipal solid waste site. As part of the upgrade activities, approximately 5,000 cubic metres of hydrocarbon-contaminated soils will be moved and remediated. Contaminated soils will be remediated in a lined engineered land farm. The land farm will be located adjacent to the new Rankin Inlet Municipal Solid Waste Site and accessed from the same road. The site was selected by Government in consultation with the Hamlet of Rankin Inlet. The tentative construction plan of the land farm is scheduled to begin the summer 2009 and remediation should be completed after approximately 5 years.

The proposed project activities include:

- Existing road use to access the site;
- Construction and operation of land farm with monitoring wells; and
- The engineering equipment and vehicle use include:
 - o Cat D6 Bulldozer – (Grading, compacting)
 - o Dump Truck 10 yard – (Transport soil)
 - o Cat 950 Rubber tire loader – (Manage soil)
 - o Smooth Drum Compacter – (compaction)
 - o ½ Ton Pick up trucks – (Personnel carriers)

- Fuel Truck – (Fuel Transfer)
- Water Truck – (Soil compaction)

Be advised that NIRB is copying interested Parties and municipalities most affected by your project proposal. Interested persons are encouraged to comment directly to NIRB by **May 07, 2008**.

The NIRB would like Parties to provide comments regarding:

- Whether the project proposal is likely to arouse significant public concern; and if so, why;
- Whether the project proposal is likely to cause significant adverse eco-systemic and socio-economic effects; and if so, why;
- Whether the project is of type where the potential adverse effects are highly predictable and mitigable with known technology, (please provide any recommended mitigation measures); and any matter of importance to the Party related to the project proposal.
