Hi Assol,

I am not sure if you want CIRNAC to respond to Jackie's question, but just in case you do, below is CIRNAC's clarification.

CIRNAC is requesting the detailed descriptions or plans of the proposed activities. Such information would help CIRNAC to assess the potential impact of these activities on water. For such purpose, the detailed design specifications and drawings may not be required at this time.

More specifically, CIRNAC would like to review the complete ***Plan of Construction Operations***, instead of just the last page of the plan. Similar request applies to the proposed activities associated with the aggregate and borrow sites. Also, detailed descriptive information should be provided on how the landfills will be capped, on where, why, and how the sampling wells will be installed, and on how groundwater will be monitored.

I hope you find the above clarification helpful. Let me know if you have any further questions.
