Unfortunately, I'm not able to find a record for the 2017 Annual Report, however, I can see from the records that TC did not undertake any on-site activities in 2017, therefore there wouldn't have been anything to report on.

Attached please find the 2018 Health and Safety Plan which contains the updated Spill Contingency Plan (Page 31).

In regards to the sewage lagoon, Transport Canada is not the owner/operator of the lagoon and it is not part of the project scope for the Landfill Remediation. It is our understanding that it is still in operation and the airport operator would be the appropriate contact for any questions regarding the lagoon.

In addition, could you please clarify the status of the sewage lagoon at the solid waste landfill (APEC 1)? Is it currently in use? Is itTC's plan to remediate the facility?
