A. BACKGROUND

On April 5, 2018 the Nunavut Water Board (NWB or Board) provided notification to interested parties that Indigenous and Northern Affairs Canada- Contaminated Sites Division. (Licensee) had submitted a Type "B" water licence amendment application for # 1BR-RES1626 for the BAF-5 Resolution Island Long Term Monitoring Project The Resolution Island BAF-5 project extent is

Resolution Island BAF-5 (Resolution Island) is located at the south-eastern tip of Baffin Island, just outside of the entrance to Frobisher Bay, approximately 310 km southeast of Iqaluit. The facility was constructed in 1953 and was abandoned in 1972 the site was then used primarily to transmit intercepted signals to southern military stations. The camp is located at (61°35'48"N) Longitude: (64°38'20"W)

After military use of the site terminated, several environmental assessments were conducted between 1985 and 1997 which, identified and delineated contaminants of concern including copper, cobalt, lead, and mercury.

A Resolution Island Remediation Design Report is included in Appendix D of the amendment application package. Project work is scheduled to start in the summer of 2018 for 2-3 months and possibly continuing in 2019, with the mobilization of equipment to site via sealift/barge. This upon completion, all equipment will be removed from the site via sealift/barge. Throughout the construction activities, personnel will be mobilized to and from site via fixed wing aircraft and/or helicopter using the on-site airstrip.

Construction activities are related to remediation and are stated in the BAF-5 Resolution
Island Remediation Design Report
Construction activities will include the following:
☐ The supply and installation of two 900 millimetre diameter corrugated steel pipe
culverts, including the removal of existing culverts
□ Supply and installation of corrugated steel pipe culverts
□ Supply of granular fill, supply of couplings
☐ The grouting of replacement culvert into the existing concrete headwall
The licensee will continue long term monitoring activities at Resolution Island, in

The licensee will continue long term monitoring activities at Resolution Island, in accordance with the plan approved by the NWB. Year 15 of 25 of the Resolution Island Monitoring Program is planned for the summer of 2021 and year 25 of 25 is scheduled for the summer of 2031.

All interested parties were asked to review the new water licence application and provide technical comments by May 4, 2018.
