HF: What's the status with Andrew Sowdloapik. He damaged his tendon by working at the beach and working so hard. It's therefore not related with his previous conditions. He has a week of physiotherapy to do and he should be OK.</p>	
8	<p><u>Health and Safety department:</u></p> <p>RD: Tomorrow will be the last joint health and safety committee meeting. We will wrap up and provide recommendations. HF: The decon trailer at the beach was cleaned and now locked. PPE left are not perishable and can therefore stay there. All fire extinguishers and eye wash station at the beach can now be stored for the winter. RD: Will be done.</p>	
9	<p><u>Other information:</u></p> <p>HF: A wet sealift supplied the site 2 days ago. We initially requested 250,000 litres. However, we only received 173,500 litres and as such, we are facing a potential shortage next season</p> <p>HF: In terms of budget, we are at our last week for payroll. Unless additional budget is made available, camp closure is scheduled for this coming Monday. We will try as much as we can to finish the work with the surveyor and the membrane installer and will keep a skeleton team on site if required.</p> <p>HF: In terms of operations, we have 44 empty containers left on site plus 4 of them damaged. The S1/S4 beach pile was addressed. The Airstrip dump was completed and compacted. JE: A bit of compaction is still required. HF: All timber not presently used were landfilled.</p>

	<p>HF: We had a visit from tourists yesterday night. A cruise ship was by the Island and some tourists went to the beach and wanted to visit the island. They saw lights at the top of the island. We met with them at the beach and they were not allowed to visit the site as the job site is a restricted area.</p> <p>HF: The schedule will be redone. As mentioned, the site shall close on Monday. 3 charters are scheduled for Sunday. If they cannot make it, 3 charters are also reserved for Monday.</p>	
10	<p><u>Season Closure:</u></p> <p>HF: This is the last PMT meeting of the season. With the worst weather we had since we started this project (i.e. very wet in August, harsh spring), a lot of work was still achieved.</p> <p>HF: Everybody worked ideally together this season. It was good that Lou Spagnuolo was sharing the information. It made a big difference and I hope we will work like this next year.</p> <p>HF: There will be a PMT meeting in Ottawa on October 20. Lou wants to discuss any outstanding issues. Those concerned will soon be advised by e-mail and will receive an agenda later.</p>




