Submission of Tailings Freezeback Report

A. PROJECT DESCRIPTION

On May 10/10 the Nunavut Water Board (NWB or Board) distributed the Mar. 5/07 EBA Engineering memo that was prepared for the Indian and Northern Affairs Canada Contaminated Sites Program (INAC–CSP). This memo, referred to as the Tailings Freezeback Report was submitted pursuant Part E, Item #12 of the Roberts Bay and Ida Bay Mine Site Remediation Project License, #1BR-ROB0813. The NWB requested representations from interested parties by June 10/10.

Part E, Item #12 of the License states,

"The Licensee shall submit to the Board for approval, within sixty (60) days of License issuance, a Tailings Freezeback Report including data that demonstrates the likelihood of freezeback permafrost conditions within the tailings."

B. RESULTS OF REVIEW

On behalf of the Indian and Northern Affairs Canada Water Resources Division, I have reviewed the submitted Tailings Freezeback Report and have the following comments / recommendations for the Board's consideration,

- To facilitate future reviews, it is suggested that a cover letter accompany submissions identifying the License conditions pertinent to the submission.
- Part E, Item #11 of the License requires INAC-CSP to submit a Quarry Management Plan to the Board for approval before engaging in any quarrying activity. There does not appear to be a Quarry Management Plan available for review on the NWB's online public registry. If quarrying activities have occurred during the 2009 tailings pond remediation or to provide cover material or for any other reason, INAC-CSP should notify

- and provide the Board with details of the quarrying activity along with the above-referenced Plan as required by the License.
- INAC-CSP's Mar 4/10 2009 Annual Report submission states that the tailings pond has been remediated through the construction of a nonhazardous waste landfill overtop in its cover design. INAC-CSP is required to submit as-built drawings for this remediation work to the Board as per Part E, Item #15 of the License.
