Hello Richard,

Crown-Indigenous Relations and Northern Affairs Canada Water Resources Division has reviewed the Spill Contingency Plan for 1BR-ROS1727 and 1BR-SAR1727.

The Plan refers to using drip trays during refuelling. It is not clear if this means fuel drums will be stored on site, or perhaps the aircraft will be transporting their own fuel for unexpected weather. If drums are stored on site, more information should be provided in the Plan, including the drum cache locations and secondary containment measures.
