Good morning Raquel,

Just wanted to follow up on your Amendment Application and clarify a few things.

From my understanding, the incinerator will be installed within the approved footprint, and the ash generated will either be disposed of at the municipal landfill or sent to an authorized facility in the south for disposal.

The NIRB's Screening Decision indicated that the unit will not create additional risks for freshwater.

Therefore, if you do not intend to alter the water use and waste disposal conditions covered under the current Water Licence, and there are no additional risks associated with this modification, then there is no need for an amendment.

Please be advised that you will be required to update all relevant Management Plans once the unit is installed.
