Dear John Davidson:

On December 20, 2010 the Nunavut Impact Review Board (NIRB or Board) received Public Works and Government Services Canada's (PWGSC) "Disposal at Sea of Dredged Sediments, Pangirtung Fjord" project proposal from Environment Canada (EC).

It is understood that the current application is associated with a previously-screened project proposal, Fisheries and Oceans Canada's (DFO) "Pangnirtung Small Craft Harbour Development" project. The NIRB previously assigned this project proposal file number 09UN052, and screened it in accordance with Part 4, Article 12 of the Nunavut Land Claims Agreement (NLCA).

On January 28, 2011 the NIRB invited interested parties and municipalities most affected by the PWGSC's "Disposal at Sea of Dredged Sediments, Pangnirtung Fjord" project to provide comments directly to the NIRB by February 17, 2011.
