#### Comments:

# A. Background

On March 4, 2014, the Nunavut Water Board (the "NWB") provided notification of Fisheries and Oceans Canada's application to assign water licence #1BW-DUV1214 to the Hamlet of Pangnirtung. This licence authorizes the use, maintenance, and eventual abandonment of a watercourse crossing (Duval River) and associated drainage redirection structure that were constructed in support of the Pangnirtung Small Craft Harbour Project.

Fisheries and Oceans Canada's application form includes

- a) A signed application for assignment and declaration of licensee;
- b) A signed undertaking of proposed assignee;
- c) A signed affidavit of execution, undertaking of proposed assignee; and
- d) Water licence application fee payment (\$30.00)

Furthermore, a project summary and written confirmation that the Hamlet of Pangnirtung will assume responsibility for the licensed undertaking were provided.

The Duval River Crossing and associated drainage redirection structure were constructed in October 2009 by Fisheries and Oceans Canada to facilitate the construction of the Pangnirtung Small Craft Harbour Project. Construction of the harbour was completed in September 2013. The Duval River Crossing consists of metal culverts and rock fill. This crossing is required for heavy equipment access to the municipal quarry.

Interested parties were asked to review this application and provide comments by April 4, 2014.





## B. Results of review

On behalf of Aboriginal Affairs and Northern Development Canada, the following recommendation is provided:

# 1. No issue with assignment of licence

**Comment:** It would be prudent for water licence #1BW-DUV1214 to be assigned from Fisheries and Oceans Canada to the Hamlet of Pangnirtung because the Small Craft Harbour Project has been completed and the Hamlet of Pangnirtung will continue to use the Duval River Crossing to access its municipal quarry.

**Recommendation:** AANDC has no issue with the licence assignment application.
