Hi Shaun,

I have talked to the Board about this approval and how to process it more than a year in advance of the work planned. As I have already mentioned before, the Board's approvals are only valid for a year. So if we issue this approval now, then it will be valid from July 2022 to July 2023. Is it very critical to issue it right now or you can wait until we issue it in let say October? This way it will be valid from October 2022 to October 2023, which should cover the construction period.
