Hi Valerie,

The activity of building a road involves construction of water crossing that wasn't requested and is not unfortunately included within the scope of current municipal licence 3BM-GJO1828. As per Nunavut Waters Regulations any use of waters related to the construction of a structure across a watercourse that is less than 5 m wide at the ordinary high water mark at the point of construction requires an approval without a licence. The NWB approval without a licence is up to one year approval, and I am attaching the form for this approval. The processing of approval without a licence is NWB's internal process and less time consuming than amendment to the licence.

Please let me or Richard know, if you need more information regarding the application details.
