Please see attached the English and Inuktitut summaries. We plan to collect the samples as soon as possible after receiving the approval (between October 16 and October 22nd, 2016). Given the expected frozen conditions, it is anticipated that the samples will be collected by breaking a small hole in the ice (approximately 30 cm in diameter) using an ice pick to collect the water. The water will be collected by dipping the sample containers directly into the water.
