Water usage is approximately 2000 litres per day. This though is only in full processing, of which would be 12 to 15 days. On storm days, or non working days, approximately 200 litres per day, as the majority of staff have returned to the community.

WASTE (for each type of waste describe: composition, quantity (cubic metres per day), methods of treatment and disposal, etc.)**Sewage:** collected in honey bags, and disposed at the approved waste disposal site**Solid waste,** hazardous material if any, waste oil, generated in the course of camp & abattoir operations will be disposed of in an approved waste disposal site.**Grey Water:** will be discharged a minimum of 30 meters from any body of water, and where any flow into a body of water is not impossible.**Other:** All non-edible condemned portions of the caribou, including viscera, heads (antlers removed) and hides will be transported to a designated area (minimum ½ mile from camp) to allow for freezing before loading onto Bombardier skids for transport to local community dump.
