**Re: New Application for Type “B” Water License**

Dear Parties,

On May 19, 2005, the Nunavut Water Board (NWB or Board) received an application for a Type “B” water licence to undertake exploration drilling in the Tayloyak area at 68°19’52”N and 89°32’16”W. Upon receipt of the application the NWB distributed the application for review to the parties and the public on April 10, 2007 and received comments from GN-DOE, DFO, INAC, EC, CLEY, KIA, and HTO, copies attached hereto.

In accordance with s. S. 13.7.2 of the *Nunavut Land Claims Agreement (NLCA)*, the Board has determined that sufficient public concerns have been expressed by the Ikinguak Hunter’s and Trapper’s Organization (HTO), to warrant proceeding to a hearing on this Type “B” application and the Board in accordance with 51 (2) of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act (NWBSRTA or Act)* is “satisfied that it would be in the public interest [ ] , to hold a public hearing [in this] matter relating to its objects.”

The NWB staff proposes to consult with the Parties on the appropriate scheduling of a hearing prior to providing “Notice of Hearing” as required by S. 55 (2) of the *Act*. A teleconference with the Parties is proposed as follows:
