Opening prayers by Gideon Qaujuaq at 7:30PM

Peter - thank the public for coming to the meeting. Read the application from Indicator Minerals Inc. for license to the Nunavut Water Board.

Agnowyuk – Explain to the Public about the meeting.

Sam .T. – Give us your concern we ask for your help on this matter.

David Igutsaq – Fishing habitats .Not to disturb our fishing area.

Gideon Qaujuaq – The area is Caribou calving ground. The Government always making rules we Inuit can't make rules on our own land.

John Ukuqtunnuaq – No fuel cast in the area. The mining Company should give 15% to the Hunters & Trappers.

John Mannilaq – Don't want the application approved due to importation of our water.

Mary Ittunga – Don't want application approved. Wants Hunters & Trappers to get help from the Nunavut Wildlife Management Board on this matter.

Agnowyuk Alookee – Myself and my husband went for ride summer time. This area we are talking about is very importation because that where all the Caribous go by we have seen caribou hair, Snow geese lots and lots of them. I think anyone or anybody shouldn't be working there.

Mary Neeveacheak – Why do we have Nunavut no one listens to our commends and concerns. One white said that gas will be hauled up there this guy is in town right now the one that said that.

Naluqiaq Peetooloot – My parents hunted in this area a lot for their meat and survival. This is a good hunting ground and should not be disturbed .

Gideon Qaujuaq - It's a good thing that the Nunavut water Board wants more input. Just when snow starts to melt water starts to flow, and anything that on top goes down with the flow Lets take more responsibility .

Mary Karoo – Before there was white we were around this area preparing meat ,dry meat etc. I now this land I walked on it years and years ago. I don't want this area disturbed. After they work it just gets left alone all destroyed don't let any one work in this area .

Joe Tulurialik – We all agree in this meeting place that no one should work in this area I think this has to be more further discussed and not worked on. Like green peace we should really get together and let people sign up on sheet, and I think we should get someone to go up and take pictures and do some studies on the people up there and report back to us.

Inuk Charlie – It's been along time since someone been working up there and as I speak a twin otter haul some drums of gas 40 miles north of here but that shouldn't go ahead right now it's just a exploration camp. I think we should really do something about this, We see Indian on Indian what they do, we should really do something here like that talk to the federal Government reason why they want license from water board is because they want to do some work for sure.

Gideon Qaujuaq – Lets not lose the lake where we do the commercial fishing.

Joe Tulurialik – We are told that Taloyoak has a good tasting Arctic Char from Yellowknife,Iqaluit and other places,Lets not lose this lake .

Inuk Aiyout – Around 1970 I've seen some drums and some equipment left up in that area, I don't want anyone working in this area for the sake of the wildlife and the plenteousness of this area.

Anowyok Aiyout – We all understand and agree that we don't want anyone to work in this area us Inuits always loose .In any subject all the time lets not lose in this one.

Sam Ogruk – There was a plane flying around last year The pilot said he was working for mine In Indian reserve or land miners used to work and after they were done Indians had nothing for themselves but lost everything ,but only after years of negation they were finally compensated.

James Sattuq – all this comment from you is all helpful and it will help like you said this should not go ahead.

David Irqqiut – Hunters & Trappers have a power in the agreement in the land claims. Before these guys really start you guys (HTO Board) should start something here towards this discussion . I think this area should be put into park of somesort. I'm happy for what you are doing this is a start and should not be just left alone. If you want this area put aside like this area we are talking about scientist, KIA can help you in starting in the area of this concern, I can help put something together to do something about this issue.Start with the water board or the media (C.B.C.)

KIA, GN , NWB , NIRB, If these guys really want to work there. They will ask for thing from NWB but just before they start work they will ask NIRB .But they will ask the HTO's before they really start.

David Igutsaq – I worked with Polargas if they were to put pipeline in, after they finish work that pipeline will always be there.

Sam Tuluiialik – Thank the Public for coming to the meeting.
