Re: Application Acknowledgement and Additional Information Request for Terrane Metals Corporation's "Maze Lake Project, Kivalliq" Project Proposal

Dear Patrick Lengyel:

On May 24, 2007 the Nunavut Impact Review Board (NIRB or Board) received a conformity determination for Terrane Metal Corp.'s Maze Lake Project Proposal from the Nunavut Planning Commission (NPC). The NIRB has assigned this project proposal file number 07EN048.

The NIRB is screening this application subject to confirmation from the NPC that the project proposal does have a positive conformity determination, there is no NPC-approved variance associated with the project, and that the appropriate appendices for Caribou Protection Measures (CPM) on Inuit Owned Land are now associated with the conformity determination documentation. Should the NPC indicate at any time that this file does not have a positive conformity determination, the NIRB shall cease screening this proposal until the matter has been resolved

The NIRB has undertaken a preliminary completeness check and finds that your project proposal does **not** contain sufficient information for the NIRB to conduct an environmental screening. Specifically, the NIRB is requesting submission of the following information within 3 weeks from the date of this letter (i.e. July 8, 2007):

- *NIRB Part 1 Summary Application Form in English (attached)*

- *NIRB Part 1 Summary Application Form in Inuktitut (attached)*
- *Non technical Project Proposal Summary in Inuktitut*
- *Proposed Project Workplan including Timelines*

It is in Terrane Metals Corp.'s best interest to address the above deficiencies in a timely manner. Failure to address these deficiencies before the NIRB resumes the screening process may result in the Project Proposal being returned for clarification in accordance with the Nunavut Land Claims Agreement (NLCA) Section 12.4.4 (c). If Terrane Metals Corp. determines that the time required to resolve the deficiencies is significantly greater than 3 weeks, the NIRB advises that they consider canceling their Project Proposal application with the Kivalliq Inuit Association and NIRB and re-filing their Project Proposal with the requested information.

If the Terrane Metals Corp. determines that the deficiencies can be resolved within a reasonable time period, the NIRB advises they notify the NIRB on or before the expected submission date. If no further information or notification is received by NIRB before July 8, 2007 the NIRB shall resume the screening process at Terrane Metals Corp.'s own risk.
