An assignment application has been acknowledged by the Nunavut Water Board on May 31, 2013. The file is still undergoing an Preliminary Technical Review and there are outstanding documents that need to be submitted as required under the terms and conditions of water licence 2BE-TRN0813. The required submission are;

- Annual Reports from 2008-2013
- Revised Spill Contingency Plan
- Abandonment and Restoration Plan
- 2010-2013 Summary Reports indicating water usage and waste disposal activities

As the licence is already expired please note that once all the information is submitted the assignment may be processed, and the expired licence may be assigned to the new Licensee without however authorizing any water use and disposal.

Another option would be to renew the licence then assigned it to the new company.

The third alternative option would be processing the assignment and renewal together. However, this is not generally the most preferred option for the Board, and you would need to include a full renewal application.
