Hi Phyllis

I am editing a few changes to the 2008 and 2009 annual reports on the Turner Lake Project, adding details as requested in the license, but before they are submitted to you I have calculated the water used for drilling.

In 2008 a total of 2534.4 m<sup>3</sup> used over 44 days or an average of 6.94m<sup>3</sup>/day for the year.

In 2009 a total of 576.0 m<sup>3</sup> were used for drilling over 10 days for a yearly average of 1.58m<sup>3</sup>/day.

No water has been used since 2009.

Can you please indicate what the company still owes the Water Board based on these calculations.
