Mr. Bridge:

Thank you for email dated August 27, 2008 pertaining activities in Nunavut that I received via Mr. Richard Cote, Vice President Exploration for Savant Explorations Ltd. ("Savant"); however, please note for your records that all email addresses with "pacifica-resources.com" have not been valid since August 31, 2007. Also, please be advised at as of May 31, 2007, approval was given at our shareholders annual general meeting ("AGM"), for several mineral properties owned by Selwyn Resources Ltd. ("Selwyn") - that was previously known as Pacifica Resources Ltd. (company name changed by novation at AGM on May 31, 2007) - in Nunavut to be sold to Savant, as part of the Savant Plan of Arrangement. This sale of assets included the Yava claim group that is described under Water License NWB2YAV0507; meaning as of May 31, 2007, Selwyn did not own the Yava claim group.

As a result of this sale, Selwyn did not, nor did it ever intend to undertake any exploration activities in 2007; noting that no exploration activities were ever budgeted for 2007 because of the impending sale to Savant. As such, Selwyn has no "annual report" to file to the Nunavut Water Board; therefore please let this letter serve as official notice to the Nunavut Water Board. Any work undertaken for Water License NWB2YAV0507 after May 31, 2007 would have been undertaken solely by Savant and therefore it would be Savant who would be filing an "annual report".

Subsequent to that AGM on May 31, 2007, Selwyn has been working closely with Mr. Richard Cote, Vice President Exploration for Savant, who has transferred both ownership and permits to Savant when required, as part of the regulatory process, with various Government and Quasi-Judicial Regulatory bodies. Selwyn therefore requests that the Nunavut Water Board amend their records with reference to Water License NWB2YAV0507. This means that all future communications referencing Water License NWB2YAV0507 in the Raptor Lake area, Kitikmeot, Nunavut should be with Mr. Richard Cote of Savant, who can be reached at +1 (604) 682-5474 extension 359.
