Hi Don,

Here is the information we discussed over the phone:

- 1) We will not be using the Sarcpa Lake landfill. Our waste waters (dishwater) will be dumped in a deep hole dug in gravel.
- 2) We were informed by INAC that the water at Sarcpa Lake had been tested and is OK for human consumption. An INAC crew was camped at the same location last year.
- 3) Flycamps will be located near 84°W and 67.5 °N, within a radius of ca. 50 km.
- 4) Flycamps will use water from local lakes or rivers. Waste water (essentially dishwater for a camp of 2 to 3 persons) will be poured in a hole dug in gravel, which will be re-filled at demobilization (after 1 to 2 weeks). Garbage will be brought back to main camp at Sarcpa to be incinerated.
