Good Day Richard,

In response to the NWB's request dated May 11, 2009:

1. Will any wastes be deposited using the CAM-F (Sarcpa Lake) Waste Disposal Facilities?
No.

2. Confirmation that the proposed water supply is safe for human consumption;

The following was received on January 8th, 2009 from Mark Yetman, Contaminated Sites Project Manager at INAC in Iqaluit:

" Drinking water: we obtained drinking water from Sarcpa Lake (via water truck). The water was tested to ensure compliance with drinking water guidelines. The small lake just to the north of the airstrip was used during the DEW line operation but we never used this source. "

3. Provide Latitudes and Longitudes for the fly camps, if this info is not available please provide general area;

Lat-longs of the fly camps cannot be provided at this time, as their locations have yet to be determined. However, and generally speaking, they will be situated along the southern limit of the 2009 map area that is highlighted on the attached map (also included in the original application).

4. Provide water source and waste disposal information for fly camps.

Fly camp locations will be chosen based on their proximity to a continuously flowing water source (i.e. a river). A maximum of 20L of water will be taken from the source each day, to be used for drinking and cooking purposes only. Waste will not be disposed at fly camp locations but will be taken back to the main Sarcpa Lake camp and incinerated in the Smart Ash that will be on site.
