Please find attached our reporting form for 3BC-GLF1111.

The location was near the head of Glacier Fiord, southern Axel Heiberg Island (78.6027N, 81.8370W; see photo attached).

The photos in the Inspection Report appear to be from Expedition Fiord area on west-central Axel Heiberg (based on the salt).

The Glacier Fiord camp was occupied from 04 July to 20 July 2011. There were five people at site. Water use was approximately 20 litres per day for drinking, dishes and washing. Waste water and sewage were disposed in a sump and buried. Solid waste was removed by aircraft.
