Kugluktuk, NU. Marine Re-supply Site Relocation. Construction of Breakwater and Causeway/docking facility.

The purpose of this correspondence is to request a Water Licence for the construction of Breakwater and Causeway/Docking Facility for the new Marine Re-supply Site in Kugluktuk, NU. The Applicant for this work is the *Government of Nunavut (GN), Department of Public Works and Services (PW&S)*. The client is the *GN Department of Community Government & Transportation (CG&T)*. The Government of Canada is the agency responsible for the Marine Resupply Infrastructure in Nunavut. They are providing the project funding in the amount of \$1.2M.

The Applicant has retained the Consultant *Jivko Engineering* of Yellowknife to submit applications to obtain required approvals before proceeding with the project. *Jivko Engineering* is also the designer and construction manager for the project.

The proposed new Marine Re-supply Facility comprises Breakwater, Causeway/Docking Facility, Marshalling Area, Access Road and Fuel Pipeline with Manifold. The construction of the Breakwater and the Causeway/Docking facility are subject to this application.

The GN, Department of PW&S with the support of the Hamlet of Kugluktuk is proposing to complete this project in spring and summer 2002.
