Regards to the river at Aliarohik, I have talked to the elders about the river this year and last year.

They say the fish run is about late week of June also part of July. They don't know if the fish go up stream in August, they use to camp at Aliarohik river in June and July went the fish run down and they go up in July.

The Kugaaruk river run is in July & August but they are not sure if the char go up to Aliaruhik. We think some go to Barrow Lake in August, but maybe few.

They know that they come down in June and July to Barrow Lake and to Aliaruhik Lake.

The Lake trout stay in Barrow lake and in Aliaruhik lake, they don't migrate like the arctic char.

Re: Road crossing



We the Elders Committee of Kugaaruk are aware of the Hamlet of Kugaaruk is looking at putting a bridge at the Ailliarusiq River on the mouth of the Barrow Lake and we support the Hamlet on the construction of the bridge for the second crossing.

We had attended the public meeting in regards to the DEW line site clean up early in March and were very grateful and the concerns from each of the government department and we share the same interest. We also want to point out some knowledge that we observed with the fish runs in the past 2 to 3 decades. We know for a fact that majority of the fish travel in the main river, which is the Kugaaruk River and that the abutments of the bridge will not cause any effect on the fish migrations.

Also that the minority of the fish travel through the Ailliarusiq River and to put an abutment on the river will not cause any harm to the fish migration and will not destroy the fish habitat.

In July of 1999 the Hamlet Council approved the location of the clear-span bridge to cross the Alianusik River. When the discussion expanded to include an extension of the road and a second crossing in November of 1999 we again approved.

The Hamlet Council supports this project to the fullest extent. We have modified our design of the crossing from its original form and are now moving forward with the portable bridge option. This option will substantially reduce the possibility of damage to fish habitat in the area of the span.

We are looking forward to finalizing the last remaining details and having the road and second crossing completed by summer of this year.
