This letter is to inform you on the status on the above application for Fisheries Act Authorization. At this time we are waiting for the proponent to provide an environmental assessment study (requested in June 2001), and a fish habitat compensation plan (requested in January.) We require this information in order to properly assess potential impacts of the project on fish habitat, and provide advice to the Nunavut Impact Review Board. Also please find attached, as information, a DFO Inspector's Directive outlining habitat concerns on a recent bridge construction project implemented by Jivko Engineering on the Aliaruhik River.

Mr. Jivkov:

On June 20<sup>th</sup>, 2001 The Department of Fisheries and Oceans personnel conducted an inspection of work, (river crossing) being carried on at Aliaruhik Lake near Pelly Bay (Kugaaruk), Nunavut. The inspection revealed that the Rip Rap at the abutments of the bridge was very poorly placed and there was loose gravel deposited on the Rip Rap, as well as on the ice, which could be washed into the river. Also the approaches to the bridge require stabilisation to prevent erosion.

Section 35 (1) of the Fisheries Act states that it is an offence to carry out any work or undertaking that results in the harmful alteration, disruption or destruction of fish habitat.

**ALSO**

Section 36 (3) of the Fisheries Act states that no person shall deposit or permit the deposit of a deleterious substance of any type in waters frequented by fish or in any place under any conditions where the deleterious substance or any other deleterious substance that results from the deposit of the deleterious substance may enter any such water.


As a result of the inspection the Department of Fisheries and Oceans is directing you, under the authority of Section 38(6) of the Fisheries Act, to take on the following reasonable measures which will lessen the chance of harmful habitat alteration or destruction now or in the future at this site.

**Canada**

1. Remove all loose gravel from areas of Rip Rap.
2. Implement proper erosion control measures to prevent sediment from entering the water during and after construction. These measures will include:
  - a. Reconstruct the Rip Rap at the abutments of the bridge.
  - b. Rip Rap the approaches to the bridge.

It is also recommended that all workers be briefed on impacts to fish habitat associated with bridge construction activities, and implementation of mitigation measures to prevent harmful alteration, disruption, or destruction of fish habitat.
