Hi Jimmy.

I am going to forward you some emails exchange I had with the airport authority and Coral Harbour SAO back in 2008, so that you get a hold on the situation of that bermed cell. The cell have to be registered. (Although I am pretty sure some soil can be put there, and had been put in the past). It is up to the hamlet to take action on this matter (with the Water Board, CG&S and airport authority), as far as contaminated soil disposal is involved. Then we can discuss how to do it. For liquid oil, glycol, it has to be stored by the hamlet until they have enough to ship down south; this would be done in conjunction with CG&S in Rankin Inlet.

I copy the SAO, as he may not be aware of past communications.
Please read all the emails I am forwarding.

Since the original request to use that area came from the Hamlet of Coral Harbour, and since you are lucky enough to have one already built, could you engage the process of having it registered ? It will then be possible to treat all the contaminated gravel/soil in Coral Harbour, instead of contaminating the local dump.

Contact C G & T , in Rankin Inlet to know how to do it. You may also enter in contact with the Hamlet of Rankin Inlet since they too, are in the process of registration their own landfarming facility. (SAO Paul Waye.)

That land farm cell was constructed by the Hamlet of Coral Harbour under a Full Authority Agreement with Community Government & Transportation.
The intent of it was that the Hamlet would remediate contaminated soils from the airport site under contract to CGT, and then use it for other soils once that was complete. The site never got registered, and the program never got off the ground.

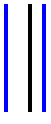
