We have received the attached proposal/permit application from Kitikmeot Foods Limited. The proposal is to commercially harvest and process muskoxen on Victoria Island, with the operation based out of Cambridge Bay (as in previous years). The project is planned to commence in mid-February.

Also attached are the draft permit conditions that we would attach to the permit.

In previous years there was some question on whether or not a water licence was required as the processing will be taking place within the community.
