Since our initial communication, some wrenches were thrown into the works: firstly, we found we were not assured of a drill--that has been resolved this week, we will have a unit and crew from Major: secondly, Dundee is not honouring the deal struck with Bill Cronk to use their camp at Goose Lake and we have just reached a deal with North Arrow to use their camp at Musk, in which we will take over this facility and request transfer of existing permits to (Skybridge Development Corp.)/Alyris Gold Corp.. This requires some minor modification to the water permit application as submitted in addition to the additional documentation requested.
