Hi Sherry,

As per our conversation yesterday, you had requested some clarification as to the content of a compliance report once your clean-up has been conducted. Basically, I require confirmation that the issues identified in the inspection report have been dealt with, and how.

A compliance report shows the proof of compliance once your commitments (under the licence and compliance plan) are finalized. In your case, as you are planning a final removal and restoration of the camp site, you can combine this report with your report on the final site clean-up. I would recommend as separate report or letter when "administrative" issues have been addressed.

Please note, that your compliance commitments under the water license tie in with the Abandonment and Restoration plan submitted to (and approved by) the NWB. The A&R plan describes your commitments regarding the final cleanup and includes mention of the details to be documented in the final report.

This report includes such items as:

- -photographs (before and after) and gps coordinates (NAD 83) of camp, fresh water sources utilized, fuel caches and drill sites (where applicable)
- -specifics on the type and quantity of waste removed from site; confirmation of backhaul to an authorized waste disposal facility
- -photos of drill sites (confirms final condition)

The Annual Report submitted in 2009 (by RT Chataway) is a good example -the final report would summarize past activities and demonstrate these sites are clean (via photos). Photos were lacking with the 2009 Annual Report (as per above note).
