Following is an assessment of the above five files:

2BE-HBP1116 Issued May 27, 2011, expiry November 30, 2016

Annual reports confirmed as received on November 13, 2013 for 2011 and 2012. These will be distributed for information as soon as possible. Water use fees have been paid for 2011 and 2012. Outstanding is the \$219.00 which was due on May 27, 2013 for the 2013/14 year. Please note that fees are payable on the amount of water “authorized” under the licence and not the actual amount used.

2BE-CAN0608 Issued June 5, 2006, expiry September 30, 2008

All fees are paid up. Annual reports are on file for 2006 and 2007. There was no annual report received for April 1, 2008 to September 30, 2008. If there was no activity on site for those months then a letter indicating this should be provided. The application for cancellation is on hold awaiting a final inspection from AANDC authorizing the Nunavut Water Board to cancel the licence.

2BE-TRE0608 Issued June 5, 2006, expiry September 30, 2008

All fees are paid up. Annual reports received and on file for 2006 and 2007. Again there was no annual report for April 1, 2008 to September 30, 2008. If there were no activities on site for that period, a letter should be provided. The application for cancellation is on hold pending a final inspection from AANDC authorizing the Nunavut Water Board to cancel the licence.

2BE-SIL0709 Issued May 17, 2007, expiry May 31, 2009

All fees are paid up. Annual reports are on file for 2007 and 2008. I’m assuming that since the licence expired on May 31, 2009 there was no activity for April 1, 2009 to May 31, 2009. Please clarify. This file is currently out for review and comments and will not be cancelled under the Water Board receives a final AANDC inspection and authorization to cancel.

2BE-NTI0507 Issued July 5, 2005, expiry July 31, 2007.

All fees are paid up. An annual report is on file for 2005. A letter received in 2006 indicates that no activities were conducted on site for the year 2007. Would this be the same for 2007? Please clarify. The application for cancellation is currently incomplete as per previous correspondence.
