

Records Review:

During a review of the Final Restoration Plan (FRP) submitted (May 2009), several discrepancies were identified between the activities reported in the FRP and those listed within the Annual Reports (located on the NWB ftp site). The Licensee is to provide clarification on the following:

- i) The 2003 Annual Report indicates that the Heequo Camp was not utilized during the 2003 field season; the FRP says it was.
- ii) The 2005 Annual Report states that the Camp was used during the 2005 field season; the FRP does not mention activity after 2004.
- iii) No Annual Report was found for 2002; FRP indicates that the camp site was used in 2002 for an exploration program.

As per the FRP, no drill programs have been reported on the property. Licensee is to confirm this is accurate.

It is reported in the FRP that the site was cleaned up by Discovery Mining Services in late 2008; however, no confirmation was provided for specific requirements listed under Part I (Conditions Applying to Abandonment and Restoration) of the water licence.

Part B: General Conditions

The description of final clean-up activities submitted by the Licensee does not provide sufficient detail to confirm the Licensee has met the licence requirements with respect to abandonment and restoration of the property. As per section 2 (iv), the Licensee is to provide a description of all final reclamation work undertaken.

Part D: Conditions Applying to Waste Disposal

As per section 5 and 6: Licensee shall maintain records of all wastes disposed of and records of confirmation of proper disposal of backhauled waste. Licensee is to provide copies of these records from 2005 to 2008 to the Inspector for review.

As per section 8: Latrine pits are to be treated with lime and covered with native material prior to abandonment. Licensee is to confirm if lime had been used prior to decommissioning.

Part I: Conditions Applying to Abandonment and Restoration

The Licensee to confirm/demonstrate that each applicable section of Part I has been met. Several specific sections are brought to your attention, based on the 2009 inspection findings of water licence 2BE-PER0610, also held by Diamondex Resources in the Kitikmeot region.

As per section 3: Licensee shall backfill and restore, to the satisfaction of an Inspector, all sumps to the pre-existing natural contours of the land.

As per section 4: Licensee shall remove from the site infrastructures and site material.

As per section 7: In order to promote natural growth of vegetation....all disturbed surfaces shall be prepared by ripping, grading, or scarifying the surface to conform to the natural topography.

As per section 11: All disturbed areas shall be contoured and stabilized upon completion of work and restored to a pre-disturbed state.

Summary

Licensee's request for file closure is denied at this time, until it can be demonstrated that the requirements for abandonment and restoration under the water licence have been fulfilled to the satisfaction of the Inspector.

The Licensee is to submit the required information and documentation to the Inspector and NWB, no later than Apr 30, 2010.

An inspection is anticipated to occur during the 2010 summer field season.
