This letter acknowledges receipt on August 12, 2013 of an application from Newmont Mining Corporation to cancel Water Licence 2BE-KAZ1011 (Application). In accordance with Section 43(1) (c) of the Nunavut Waters and Nunavut Surface Rights Tribunal Act, the Nunavut Water Board (Board or NWB) may cancel a licence on application by the licensee.

To ensure this application is dealt with in a timely fashion, the NWB forwards notice of all documentation to regulators and council of the municipality(ies) most affected by the project, inviting interested parties to make representation directly to the NWB within 30 days from the date of this letter.
