Hi Eva,

Hope you're well and that you had a good field season! We did some work up in the Lac de Gras area in August and managed to get out to two old sites that you had visited last year – Canoe Lake (2BE-CAN0608) and Silvertip (2BE-SIL0709). Attached please find summaries of our clean-up efforts at both locations. Each report includes a table with the locations we visited and removed debris (with coordinates), also included are before and after pictures of all items you noted in your original reports that were to be removed. Once you've had a look through the reports and are satisfied, we would like to move forward with the cancellation of these two licenses. We submitted cancellation applications for both of these licenses back in August of last year,

and I seem to recall you mentioning that we would not have to re-submit these, can you please confirm this, thanks!
