There are some issues that may prevent the Licence cancellation, they are:

Non compliance issues:

1) The Licensee was required to submit for Board approval:

a revised SCP and a revised A&RP addressing issues identified by reviewers (Part H Item 1 and Part I Item 1, expired Licence).


2) AANDC comments on 2008 Annual Report, regarding an spill occurred on site, March 4, 2008

"The proponent should submit all documentation regarding the disposal of the waste generated as a result of the spill, including documents from the disposal site in Alberta"

3) It is not clear if the Licensee has submitted to the NWB the final Clean up Report referred by Eva Paul's email on Nov 7, 2014.

While, in my opinion, No. 1 can be waived, it is necessary that Items No.2 and 3 be addressed. Thus, the Licence cant be cancelled.
