# Re: Request for Closure - Type "B" Nunavut Water Licenses 2BE-SNN0508 and 2BE SNN0813

### A. Project Description

Stornoway Diamond Corporation is requesting the official closure of Nunavut Water Board License (NWB) 2BE-SNN0813 and its predecessor 2BE-SNN0508.

The above stated licenses held by Stornoway Diamond Corporation in joint venture with Hunter Exploration Group were authorized for water use and waste disposal in association with exploration activities on the Aviat Project located 50km west of the community of Igloolik, Nunavut. The Aviat Project is comprised of 420,000 acres with the project operating a 15-25 person exploration camp. Field activities were supported by on site helicopter and periodically by fixed wing aircraft from Igloolik.

During the spring and summer of 2005-2008 under the authorization of license 2BE-SNN0508 exploration activities (i.e. prospecting, ground geophysical surveys, geological mapping, the collection of rock and till samples, and diamond drilling) were conducted on the Aviat Property.

In 2008 the camp was put into winterized state and remained inactive throughout 2009-2011 under the authority of license renewal 2BE-SNN0813. In 2010 a representative of Stornoway visited the camp to ensure it was still in acceptable winterized condition and to ensure that the small fuel cache was free of leaks and ruptures.

In July of 2012 a small crew of personnel arrived at the Aviat Camp. The primary function was to demobilize the camp and perform abandonment and reclamation activities. All final abandonment and reclamation activities were conducted in accordance with the approved "Abandonment and Reclamation Plan for the Aviat Project".

All temporary camp structures were removed from the location over a 3 week reclamation program. All wood was incinerated in a controlled burn on bare ground. Remaining coals and ash were raked for non-combustibles to be taken back to an authorized disposal facility in Igloolik.

#### B. Results of Review

AANDC Water Resources Division offers the following comments/ recommendations for the Board's consideration.

- 1. General
- AANDC Water Resources Division finds the cancellation application complete and recommends that the above referenced license not be cancelled/ closed until a Water Resource Officer completes an on-site inspection and provides confirmation that no compliance issues are associated and/or remain outstanding with the project.

- 2. Abandonment and Reclamation
- Stornoway Diamond Corporation reports "any full fuel drums and/or canisters that had been stored at the camp location were sold to the Hamlet of Igloolik and are now in their possession (any markings indicating Stornoway's previous ownership of the drums will be removed)". AANDC recommends that Stornoway clarify whether the drums of sold fuel remain on site at the Aviat Camp and whether they are in secondary containment or have they been transferred to the Hamlet.
- In the proponents Final Land Use Report N2007C0003 it is reported that "all wood (tent floors, frames etc.) were incinerated in a controlled burn on bare ground". Under the conditions of the authorized license 2BE-SNN0813, the proponent was not authorized to conduct any open burning (a permit or authorization from the NWB is required). Part I, section 7. States that "The Licensee is authorized to dispose of all acceptable food waste, paper waste and untreated wood products in an incinerator". Given the combustible waste was burned on bare ground and not within the containment of an incinerator, the proponent is in contravention of their license condition.
