Technical Review Memorandum

1. Project Description

The Nunavut Water Board (NWB) distributed Diamondex Resources Ltd. application for licence cancellation January 21st, 2013. Due to inactivity at the TIM Project, Diamondex would like to cancel their licence.

In 2004 the initial proponent Trigon Diamond Corporation Ltd. conducted regional sampling program designed to determine if and where kimberlite bodies are present on the property. The results of this program were promising, with follow-up work continued during July 2005. The 2005 field program contained three components: airborne magnetic survey, follow-up (detailed) sampling, and prospecting. All of these activities were run by a six-man field crew with logistics based out of Kugaaruk. Only reconnaissance sampling was conducted on the TIM property.

Initially, results of the previous two exploration programs had prompted Trigon and its joint venture partners to plan a drilling program for 2006. Further analysis of the results showed that there was not enough confidence in the targets for the drill program. Therefore, a two stage sampling/prospecting program was carried out in 2006. The first phase of exploration was conducted in early July and the second phase was conducted in early September.

In late 2007, Trigon Diamond Corporation assigned the TIM project and its associated licence 2BE-TIM to Diamondex Resources Inc. Since the assignment to Diamondex Resources Inc. no work has been completed on the property (including years 2007-2012). As such Diamondex has requested the licence 2BE-TIM0813 be cancelled.

2. Results of Review and Recommendations

AANDC Water Resources Division offers the following comments and recommendations for the Board's consideration.

A. General

 AANDC finds the cancellation application complete and recommends that the above referenced license not be cancelled/ closed until a Water Resource Officer completes an on-site inspection and provides confirmation that no compliance issues are associated and/or remain outstanding with the project.
