This letter acknowledges receipt on March 27, 2014 of an application from North Arrow Minerals Inc. to cancel Water Licence 2BE-TOR1014 (Application). In accordance with Section 43(1) (c) of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*, the Nunavut Water Board (Board or NWB) may cancel a licence on application by the licensee.

To ensure this application is dealt with in a timely fashion, the NWB forwards notice of all documentation to regulators and council of the municipality(ies) most affected by the project, inviting interested parties to make representation directly to the NWB *within 30 days from the date of this letter*. The NWB may provide additional procedural instructions once the application has been reviewed by interested parties.

The Board further requests that Aboriginal Affairs and Northern Development Canada advise the Board when a final site inspection is complete. At that time the Board will make a determination on the Application.
