Good morning Gordon,

In follow-up to our brief telephone conversation yesterday, I checked our records and with Phyllis Beaulieu, our Manager of Licensing, and found that the NWB was not in receipt of the spill plan addendum that was required 30days following licence issuance. Licensing sent out a reminder letter on March 18, 2010. I'm not sure if this is the item you were calling about? You'd mentioned fuel storage and having the KIA permits in place, but not sure if that was in reference to the SCP. For the SCP the condition reads:

The Board has approved the Plan entitled "Spill Contingency Plan, Torp Lake Project, Nunavut", dated June 2009. The Licensee shall submit to the Board for review, within thirty (30) days of issuance of the Licence, an addendum to the approved Plan addressing the comments received from INAC and EC in the application review process which include the following:

- a. Edit appendix 4 to list the substances that have MSDS's available and provided within the Plan or refer to the safety data sheets and their location at the project site (safety office, first aid, muster point etc.);
- b. Environment Canada contact info on page 7 should be revised to indicate the Yellowknife office number of (867) 669-4730 and the Inspector contact in Iqaluit (867) 975-4644. The 24hr pager is no longer in use; and
- c. Section 4, reporting of a spill should be made to the 24 Hour Spill Report Line followed by reporting to INAC, Manager of Field Operations, Ph.(867) 975-4295, Fax (867) 975-6445.

Not an onerous undertaking, should be a one or two pager, titled something like 'Addendum to Spill Contingency Plan..." dated June 2009, etc.

Item a) could be a new appendix 4 with the changes, b) change in contact numbers, and c) section 4, refer to spill line and INAC, contact numbers.

Submit with a cover letter, notice of changes. For your own benefit, following submission of the addendum, it might be good to make the changes directly to the SCP for records and have a copy on site (this revision should also include a single page "record of revisions" that indicates the changes, pg # and date). Alternatively, you could submit the revised plan so long as it contains the record of revisions page, that will identify to the reviewer where the changes were made (otherwise the entire doc will require review again).
