My Field Inspection confirmed that the area is in a clean and natural state and I am recommending closure of this LUP.

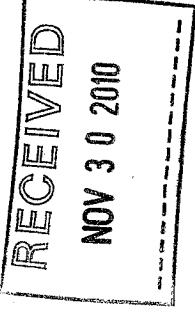
