A. BACKGROUND INFORMATION

On July 10, 2013 the Nunavut Water Board provided notification to Aboriginal Affairs and Northern Development Canada (AANDC) that Dr. Gordon Osinski, on behalf of the University of Western Ontario had submitted an application for a Type B Water Licence Cancellation, No. 3BC-AMD1212. The submitted information is as follows:

- 1. Water Licence Cancellation Application form, dated April 11, 2013.
- 2. Administration Fee Covering Letter, dated April 12, 2013.
- 3. Receipt of Administration Fee Only Cheque, dated June 7, 2013.
- 4. AANDC correspondence on Closure, various dates.

The approved Water Licence was issued on May 2, 2012 with the water to be used exclusively for camp purposes while the team of researchers carried out their study. The Application for Water Licence Cancellation was received from the licensee on April 11, 2013.

Interested parties were requested to review the information and provide comments by August 10, 2013.

B. RESULTS OF REVIEW

On behalf of AANDC, the following comments/recommendations are submitted to the Nunavut Water Board for consideration:

1. Application for Water Licence Cancellation Form

AANDC finds the cancellation application complete and recommends that the above referenced licence not be cancelled/closed until a Water Resource Officer completes an on-site inspection and provides confirmation that no compliance issues are associated and/or remain outstanding with the project.
