Hi Jennifer,

A couple of quick questions regarding the Meliadine Gold Pre-development Type B WL application:

1. A small discrepancy of proposed scope is noticed between the Application Block 9 (Description of Undertaking): Project Executive Summary (pg. i) and Main Document s. 3.3 Mine Site Infrastructure (pg. 25) regarding the installation of new portal, and conveyor ramp to the underground mine.

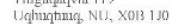
According to Executive Summary this installation is not included within the proposed scope, however, this is not indicated in the Application or Main Document.

2. Main Document's s. 5.4. Spill Contingency Plan states that *Agnico Eagle* proposes to use the approved Spill Contingency Plan which exists for current Meliadine operation, to minimize duplication and streamline emergency response in facilitation of effective communication in the event of a spill.

The "Meliadine Gold Project Spill Contingency Plan Meliadine Camp Site, Meliadine Exploration Sites, All Weather Road, Discovery Camp Site" version February 2014 is the SCP that was submitted for Meliadine exploration / advanced exploration licences and approved by the Board. If this the Plan referred in the Main Document, and while this Plan could globally be applicable for the proposed activities as well, however, the Plan should still be updated to include the proposed project specific information.
