The Nunavut Water Board (NWB or Board) requests that Baffinland Iron Mines Corporation (BIMC) provide to the Board for review at its earliest convenience a report pertaining to the activities/undertakings conducted under Type "B" Licence 8BC-MRY1314 for the period in 2013 prior and up to date on which the same licence was incorporated into the Type "A" Licence 2AM-MRY1325.

This request is consistent with a recommendation from Aboriginal Affairs and Northern Development Canada (AANDC) indicating that the above-mentioned report should be considered prior to any decision by the Board with respect to cancellation of Licence 8BC-MRY1314.
