**RE: NWB2CON9901 – PESTILENCE CAMP**

This letter is to inform you that Ashton Mining of Canada has completed reclamation of the Pestilence Camp. The camp was originally established under Water Use and Waste Water Disposal Permit NWB2CON9899 and was last used in August of 1999. The camp was demobilized in September of the same year and has sat inactive for the entire term of Permit NWB2CON9899. This most recent permit was issued on October 6, 1999 and expired on Sept 30, 2001. An extension was granted until September 30, 2002 as reclamation could not occur in 2001 for logistical reasons. The camp is located at the following coordinate:

Ashton last inspected the site in August of 2001. In the interval between our last inspection and the September 16, 2002 clean-up the camp had been vandalized and robbed. As a result the enclosed "before" photographs show the camp in a state of disarray. Lumber and garbage was flown to Yellowknife for disposal. As you will note there is a tent in the "after" photos. It was used as lodging for the reclamation staff until the next flight arrived.
